Prisons are often referred to as a breeding ground for radicalisation leading to acts of terrorism. The European Agenda on Security presented on 28 April 2015 and the Council Conclusions on the Renewed European Union Internal Security Strategy 2015-2020 adopted on 16 June 2015 prioritises the prevention of radicalisation in prisons, and the development of effective disengagement/de-radicalisation programmes.

This High-Level Conference, organised jointly by the European Commission and the Luxembourg Presidency of the Council of the European Union, with the support of the EU Counter-Terrorism Coordinator, aims at allowing policy-makers, legal practitioners and experts to exchange views on effective interventions, management and sentencing practices to avoid the spread of radicalised ideas, inside and outside prisons in the European Union, which could lead to acts of terrorism.

The expected outcome of the Conference is a contribution to finding responses in the criminal justice sector on how to deal with this sensitive and complex problem. The conclusions of the Conference will be presented at the December Justice and Home Affairs Council.
